2. Cavalier Trail / Washington Street Traffic Light Project

Presenters: Kyle King, Falls Church City Engineer Ryan Knight, Fairfax County Engineer

- Slideshow (projected) presentation displayed to meeting participants to highlight the Cavalier Trail traffic light project funded by Falls Church City. Highlights included:
  - Funding for the project was received five to six years ago from state and Falls
     Church City funding sources.
  - o Three primary drivers for the project: 1) Pedestrian concerns; 2) Increased traffic; and, 3) Beautification / Aesthetic improvement opportunity.
  - Scope of the project includes (not all inclusive): Traffic Signal, Crosswalks / push buttons, Lighting, Signage, Brick Sidewalks (similar to Tinner Hill), and Bump Outs.
  - Project currently 30% complete through Design Phase with anticipated 60% completion by Fall of 2017.
- Multiple concerns raised by Summerfield residents concerning increase in car traffic due to diversion of cars away from Cavalier Trail.
- Representative for business owners of Cavalier Trail complex identified multiple issues/concerns with current design and highlights from his previous meeting(s) with Mr. King and Mr. Knight.
- Presentation will be posted to the Fairfax County website and also to the NextDoor application by GDCA members.
- Closing thoughts from Falls Church City and Fairfax County representatives: The design is still fluid and changes can still be made. Residents should voice their concerns and opinions to their offices in the coming months prior to the design phase becoming finalized.

3. Summerfield Road Community Update

4. Cavalier Trail (walking) Update

- Anticipated "facelift" for Cavalier walking trail anticipated to begin in late Summer or early Fall 2017. Upgrades will include paved walkways measuring 5 feet across with grading over existing roots on trail.
- Engineers currently assessing the walking trail to reduce water spill over and preserve existing trees/roots.

## 5. I-66 / VDOT update

- Update on recent VDOT meetings concerning the toll lanes to I-66.
- Toll lanes opening December 2017 with variable toll rates from 0530-0930 and 1500-1900 with HOV-2 in peak directions (inside Beltway). Outside beltway project still scheduled for 2022 completion.
