

THE PRESIDENT'S CORNER

The residents contacted by our Membership Committee gave some pertinent suggestions regarding the improvement of Greenway Downs.

Monday evening, April 8, your Executive Board met with Bob Cotten, the County Supervisor representing our area. Mr. Cotten had a very informative presentation of the problems confronting us in Greenway Downs and Fairfax County. Some of the problems are not within the jurisdiction of the Supervisors, but on those that are, he has promised to give us his best cooperation and will endeavor to-do all-he-can to get the needed action we desire. (Remember, there are seven Supervisors in Fairfax County and we cannot expect him to perform miracles for us.)

We are preparing a detailed written report with specific references on the map of our area, showing the projects on which we desire action by the Supervisors, and we expect to get some concrete results. The most expensive items needed are those of drainage and improvements to our streets. We must be willing to do our part to cooperate in working out solutions to these problems.

In May we will vote on a \$29.9 million bond issue to build more classrooms to keep up with the rapid of the Federation of Citizens increase in school age children in Fairfax County schools. If this bond referendum is not approved, we will have "pure chaos" according to Bob Cotten of the Fairfax County Board of Supervisors.

8 (9 (5) (B) (B) (B) Mr. Cotten told us the County has been building a classroom a day since the 1960 bond issue. We must continue this rate of building to provide facilities to take care of an increase of 7,000 students each year. We built for 20,000 students in the last 4 year period and we must provide for 21,000 more in the next 3 years. We cannot afford even a year's delay in this program.

> The best news for taxpayers is the fact that this \$29.9 million bond issue will not necessitate raising the existing tax rate for school indebtedness because we are paying off our old school bonds and our taxable wealth is increasing.

We can be proud of the fact that thus far the forward looking people of Fairfax County have responded to the school needs of one of the fastest growing communities in the Nation with vision and effort. Our community is flourishing, our economy is healthy, and we must continue to provide the vital education system it deserves. The state of the state of

LAST MONTH'S PROGRAM

Mr. J. Morton Franklin, our speaker last month, gave us many simple and inexpensive suggestions and remedies for use in our gardening. He also told us how to prune roses, how to pinch back chrysanthemuma for maximum bloom, how to pinch back annuals to produce the biggest and best blooms, and even gave us hints on how to grow the best vegetables, He mentioned the fact that the past winter had been very hard on shrubs and lawns and told us to leave the shrubs alone until they have had a chance to come out as much as possible before pruning out the dead wood. He suggested a light seeding of lawns and also an application of fertilizer to give them a lift before hot weather arrives. He highly recommended the use of pre-emergence crabgrass killers where this is a problem, as they are most effective. We spent a most profitable and onjoyable evening asking Mr. Franklin many questions about our gardens. In fact, we didn't stop until 9:45 PM.
