On Wednesday, March 25, 1970, the following resolution was presented to and passed unanimously by the Greenway Downs Citizens Association. It is being sent to our local, State and Federal representatives expressing our feeling on this very grave and depressing problem. It is our intent to support present, pending and future legislation regarding the drug problem, as stated:

"Recognizing that drug abuse is a serious problem in our community, which can have serious mental and physical affects on the drug user and may have grave side effects upon the entire community, we hereby encourage and support the efforts of our governing bodies, public officials, professional organizations, business communities, and the public in general to effectively deal with this problem.

We also recognize the need for deterrent action imposed by the courts on those guilty of committing illegal drug acts. It is our opinion that leniency should be shown to first offenders convicted of using drugs illegally. However, those who attempt to profit financially through the illegal sale of drugs should be dealt with more severely. Specifically the use of marijuana should be treated as a misdemeanor, trafficking in marijuana or the more dangerous LSD, heroin, barbiturates, amphetamines, etc. should be considered a felony and punished accordingly."

CONSTITUTION AND BY-IAWS

or

The Fairfax County Federation of Citizens Associations, Inc.

We hereby associate to form a non-stock corporation under the provisions of Chapter 2 of Title 13.1 of the Code of Virginia and to that end set forth the following:

1. The name of the corporation is THE FAIRFAX COUNTY FEDERATION OF CITIZENS ASSOCIATIONS, INC.

3 4 . . .

2. It shall be the purpose of the Federation to sponsor and facilitate nonpartisan civic action with reference to such matters as are of common interest.

3. There shall be no shares of stock issued but membership will be evidenced by certificates of membership issued by the secretary upon election of an association.

4. The post office address of the initial registered office is: 3932 Old Lee Highway, Fairfax, Virginia 22030.

5. The name of the County in which the initial registered office is located is Fairfax County, Virginia. The name of its initial registered agent is Blaine P. Friedlander, whose business address is the same as the registered office of the corporation.

6. The number of Directors constituting the initial Board of Directors is twentysix (26) and the names and addresses of the persons who are to serve as the initial Directors are: (in the interest of brevity, the following names have been omitted.)

7. Proposed amendments to these Articles shall be submitted in writing to the delegates at least 25 days in advance of the meeting at which the vote thereon is proposed to be taken. The affirmative vote of more than two-thirds of the member associations present and voting shall be necessary for the adoption of the amendment.

8. Upon dissolution of the Corporation the Board of Directors shall, after paying or making provision for the payment of all liabilities of the Corporation, dispose of all of the assets of the Corporation, exclusively for the purposes of the Corporation in such a manner or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any of such assets not so disposed of shall be disposed of by the Court of jurisdiction of the principal office of the Corporation, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.

9. Each person now or hereafter a director or officer of the Corporation (and his heirs, executors and administrators) shall be indemnified by the Corporation against all claims, liabilities, judgments, settlements, costs and expenses, including all attorney's fees, imposed upon or reasonably incurred by him in connection with or resulting from any action, suit, proceeding or claim to which he is or may be made a party by reason of his being or having been a director or officer of the Corporation (whether or not a director or officer at the time such costs or expenses are incurred by or imposed upon him), except in relation to matters as to which he shall have been finally adjudged in such action, suit or proceeding to be liable for gross negligence or willful misconduct in the performance of his duties as such director or officer.

10. The corporation does not contemplate pecuniary gain or profit to itself or members, but at all times shall be conducted as a non-profit organization.

ARTICLE V

1. By February 28 of each year the President shall appoint a Nominating Committee of seven members, including as chairman the most recent Past President of the Federation able to serve, three (3) District Chairmen able to serve and such other members as are necessary. The Nominating Committee shall submit a complete slate of nominations, to be published in the April Bulletin, for officers and for district representatives from such districts as may not have already designated a representative under Article IV not later than the April meeting and additional nominations from delegates shall then be permitted.

2. The election and installation of officers and district representatives shall take place at the annual meeting.

3. If a vacancy occurs (in an office elected by the Federation) prior to January 1, the President (or the First Vice President, if the vacancy is the office of President) shall declare the office vacant; the Nominating Committee which served at the preceding regular election shall submit its report at the next regular meeting, additional nominations may be made from the floor at that meeting according to the procedure set forth in Para. (1) of this Article, and the election to fill the vacancy for the unexpired term shall take place at the next succeeding regular meeting. If a vacancy occurs after January 1, the unexpired term shall be filled by an appointee of the Board of Directors.

ARTICLE VI

1. The Board of Directors shall consist of the elected officers, the immediate Past President, the district representatives, and ten committee chairmen designated by the President. The President shall be the Chairman of the Board of Directors. The Board of Directors shall be the administrative body of the Federation functioning in accordance with Federation policy. Committees shall report to the Board of Directors, which will monitor and coordinate their programs.

2. Additional committees may be appointed as deemed necessary by the President, with the advice and consent of the Board of Directors.

ARTICLE VII

1. The dues shall be twenty-five dollars (\$25.00) per year for each member association from and after June, 1969. The fiscal year for dues shall begin with the election of officers as prescribed in Article V and shall end upon election of officers for the succeeding fiscal year. Payment of dues shall be made before the delegates of any new member association can be seated. Dues for new member associations will be pro-rated on a semi-annual basis.

2. Associations more than six months in arrears on dues shall be suspended from membership in the Federation. Such associations may be restored to good standing upon payment of the current year's dues.

3. The requirements of paragraphs 1 and 2 may be waived by the Board of Directors upon request from an association. Such waivers may extend for a maximum of one year.

4. Disbursements of funds will be made by the Treasurer as authorized by the Board of Directors. The Treasurer shall submit a financial report to the membership at least once a year.

5. An Auditing Committee of three to five members, a majority of whom shall not

6. Policy motions shall be submitted to the Board of Directors and reported to the delegates in writing before being presented at a meeting. This provision may be suspended by a two-thirds vote.

ARTICLE III

1. The officers shall be President, First Vice President, Second Vice President, Recording Secretary, Corresponding Secretary, and Treasurer. The President shall be the Executive Officer of the Federation and direct its operations within the policies of the Federation membership and the Board of Directors. The President shall normally preside at all meetings; in his absence the First Vice President or the Second Vice President, that order of availability, will preside. Any Committee Chairman may preside at any meeting where, in the President's judgment, the subject matter to be discussed makes this desirable.

2. There shall be one district representative for each service district of Fairfax County. Such representative, if selected by the district council, must reside within association boundaries of some member association of that district council. If the district representative is selected by the procedure for filling vacancies in Article V, Para. 3, he must reside in the service district he represents.

ARTICLE IV

1. In each service district there may be a district council of citizens associations consisting of the Presidents or duly established representatives of the associations in that district which meet the qualifications for membership in the Federation.

2. As association whose boundaries lie in more than one service district may choose in which of these service districts it elects to participate as a member of the district council.

3. No association shall claim simultaneous membership in more than one district council.

4. The purpose of the district council shall be to sponsor and facilitate nonpartisan civic action with reference to such matters as are of common interest, particularly to the citizens of that district.

6. The Chairman or a duly elected representative shall serve as the district representative for the Federation. Designation of the district representative shall be accomplished at such time as will permit recognition of the district representative at the regular March meeting of the Federation, and installation at the annual May meeting of the Federation.

7. If a vacancy occurs in the office of district representative and remains unfilled for a period of two months, it shall be filled in the manner indicated by paragraph 3 of Article V.

8. Nothing in this article shall operate to require a change in the membership of any district council as constituted at the time of its ratification, but this exception shall not extend beyond the next redistricting of the County.

1. ARTICLE II

1. Official action by the Federation shall be taken only pursuant to the vote of the membership at a regular or special meeting of the Federation.

2. The annual meeting of the Federation shall be held the third Thursday during the month of May. Regular meetings of the Federation shall normally be held the third Thursday of each month, except May, July and August. Notice of these meetings shall be given to each delegate by notice mailed at least one week before the meeting. and the set of the

3. The President shall call special meetings whenever he deems it advisable, or upon request of five member associations in writing the President must call a special meeting. The notification to delegates of special meetings shall be in writing and shall state the purpose thereof. Any matter not covered in such notification shall not be in order at such meeting.

4. Each delegate shall have one vote except as hereinafter set forth. All matters of vesting discretion in or giving instruction to delegates shall be exercised by the member association. Upon request of any delegate from a member association, seconded by delegates from two other member associations, voting will be by roll call of member associations. In such cases, each delegation shall be entitled to one vote which will be cast by the Chairman of the delegation or other delegate or alternate acting as Chairman. Except at association roll call voting, officers and Past Presidents of and District Representatives to the Federation (excluding the presiding officer, who will vote only to break a tie) shall have the same voting privileges as other delegates.

5. Delegates from at least twenty-five member associations shall be a quorum for transaction of business at meetings.
