January Meeting Minutes Approved

Treasury Report & Memberships

No significant change on the budget since last month. An analysis was done on on membership declines. Membership is in decline compared to years passed. We may offer a raffle ticket or another incentive to drive membership sales next year.

Code Ninjas

Code Ninjas had expressed interest in having a coding night for the neighborhood. We could advertise with the neighborhood signs, and use our website or another mechanism to solicit names. Jenny will get more details for the event to be discussed in next month's meeting.

Update on FC29

The task force met two weeks ago to talk about the next steps. Virginia Tech has finished their report and determined that the average household size of our neighborhood has increased over the past thirty years based on census data. Top priorities included pedestrian safety, multi-modal connections in safety (bus, bike, and road sharing), and sidewalks and infrastructure. Members of the task force will be meeting with the Falls Church Human Services Committee, Falls Church Citizens Transportation Committee, and the Northern Virginia Coalition for Smarter Growth. Next month the task force will be writing a letter of support to Falls Church City and Fairfax County to begin to include elected officials in this effort. A third community meeting is planned for April.

VDOT Update

VDOT has reported that Greenway Downs has been included in the *draft* 2020 paving schedule. More information to come.

Ongoing Projects

Upon the request of Lisa Welde last fall, Summerfield Rd., the GDCA Board submitted a request to Providence Supervisor's office for an extension of the RPPD on Summerfield Rd.
