COLA HABIT UNDESTRABLE

* * * * * * * *

The cola habit in children should be discouraged, say medical authorities, to prevent caffeine stimulation and dependence. Intemper ate consumption of cola beverages is suspect in acne, nephritis, nail-biting, nervousies, and emotional disturbances beingers. Of the 35 billion bottles of carbonated beverages sold annually in the United States, the cola drink supply by far the largest demand.

Cola is the dried nut of a tree which is cultivated ac Brazil and the West Indies. It centains 1.5 to 3.5 percent of caffeine, in addition, theobromine and its stimulating properties are considerable. A contributory cause of juvenile delinquency is excessive nervous tension which requires an outlet. To a lesser extent over dosages of caffeine accomplishes the same result as does the use of "pep pills" and amphetamine inhalers. Root beer, as compared with cola drinks, is far more wholesome for children and adoles cents and may provide a means of breaking the cola habit.

ANNUAL CHILDREN'S CHRISTMAS PARTY - 1965/

Plans are now in process for the annual Greenway Downs Children's Christmas Party to be held on SATURDAY, DECEMBER 18 in the DEVONSHIRE CAFETORIUM from 2-4 in the afternoon.

Current ARTICLE III-Membership.

Section 2. Admission to membership shall be subject to the provisions of these by-laws, and shall be effective from the first day of the membership year for which dues are paid.

Dues shall be payable yearly in advance at the rate which shall be adopted by the members following the regular Annual Meeting. consistent with the financial needs of the Association). by a majority vote of those members attending the regular meeting of the Association (The officers and directors shall recommend a rate

Section 4. The fiscal year shall be from January 1 to December 31.

PROPOSED ARTIVLE III-Wembership.

DELETE Sections 3 & 4, CHANGE SECTION 2 as follows: ADMISSION TO MEMBERSHIP SHALL BE SUBJECT TO THE PROVISIONS OF THESE BY LAWS AND SHALL BE SUCCEEDING MEMBERSHIP DRIVE IN THE FOLLOWING YEAR.
