## PRESIDENT'S CORNER

I very much appreciate the opportunity to attend the annual dinner of the Fairfax County Federation of Citizens Associations. This dinner was held to honor a citizen of Fairfax County who was outstanding in local activities. The recipient, Mrs. Elizabeth Hartwell, has been very active in the Citizens Council for a Clean Potomac, in conservation groups, and other civic endeavors. An article appeared in *The Evening Star* on March 24. I am sure many of you read the article so I won't continue to dwell on Mrs. Hartwell's accomplishments.

I do want to write about the subject matter presented at this dinner by D.C. Deputy Mayor Graham W. Watt. His subject, "Reciprocal Income Tax," is something every resident of our area, and of our suburbs of D.C., should be vitally aware of. Why does D.C. want this tax? It is probably because they do not have sufficient income to support all their requirements. D.C. has a relatively low income tax base. Many of the low income wage earners work in government agencies in Virginia. The Virginia portion of the reciprocal tax would be much less than the portion D.C. would receive from Virginia residents working in D.C. If Virginia is going to have less income tax receipts from Virginia residents because of the reciprocal tax, it will become necessary to increase the income tax rate in Virginia and/or the real estate and/or personal property tax. Virginians would, in

## \$1 MILLION A MILE

Pot holes and road widening are very interesting subjects to the Downs residents in March. In fact, Mr. L. E. Brett, Resident Engineer of the Virginia Department of Highways spoke to a rapt audience which heard about his problems of rights-of-way, \$1-million-a-mile road costs, and frost over 12" in depth.

As far as the Lee Highway widening project is concerned, the Highway Department's right-of-way department is contacting property owners and detailing what the project entails. This will take 8 to 12 months and then bids will be accepted. At present the project calls for a 68-foot road with sidewalks on both sides. From Cavalier Trail to Greenway Boulevard, the median will be painted flush and from Greenway to Graham Road there will be 4ft. to 16ft. crossover medians. Construction costs for the 7/10 of a mile will be approximately \$600,000.

In commenting on pot holes, Mr. Brett mentioned that some roads are just not there anymore due to the 1- to 2-foot frost line and the constant freezing and thawing we had this winter. He also commented that we always have a big snowfall on Christmas or New Year's Eve so that he's not even sure what goes on at New Year's Eve parties anymore.

He noted that since the Virginia Highway Department is now in court over Route 66, that project is at a standstill. However, the biggest job that he has right now is the Shirley Highway project which is ahead of schedule.

Mr. Brett expressed hope that more people would use buses. He points out that there are only 1.3 persons in a car per trip in this area. Mr. Brett also had the detailed maps of the Lee Highway project and the widening of Gundry Drive in Falls Church from Annandale Road to Broad Street.

## PROBLEMS?

Presently a few of our streets have partial sidewalks or walkways; however, according to reports, automobiles parking across, along, or over them has limited their use. With public parking facilities here, as well as sidewalks, in very limited supply, we must all make an additional effort to respect the rights of our neighbors to use these limited facilities. We can accomplish this simply following these points: Don't block driveways; don't park in

restricted areas; don't park or restrict the use of the sidewalks; and use available parking spaces wisely, leaving room for another vehicle when possible.

Another very dangerous parking situation often exists—parking on the wrong side of a street so that the car is facing traffic when it re-enters the roadway. With so many areas here with poor visibility, drivers should be particularly careful to avoid this situation. Park your car in the direction of traffic.

And, with the later hours of daylight, please watch for children on our streets.

### SPRING CLEAN-UP - MAY 3

Neighbors, here's your chance to do your Spring cleaning and not have to look at the trash along the curb for several days. A special trash collection has been scheduled for Monday, May 3, to pick up ALL your trash from attic, basement, garage, yard and closets. Spend the first weekend in May having hubby and son haul it to the street, and Fairfax County will spend Monday hauling it to the dump. If they don't get all of it on Monday, they will come back

until it's all gone. There are only three requirements for debris:

- 1. It must be easily lifted by the collectors;
- 2. Branches must be no longer than 4' and tied;
- 3. Leaves and other yard debris must be in cans, boxes, or bags.

SO-take advantage of Monday, May 3, to help beautify your yard and house, and thereby do your part to beautify Greenway Downs.
