#### COUNTY BOND ISSUES

On November 6, you will be voting on much more than President, Vice President and other federal, and state officials. There will be several bond issues with which you should become familiar so your vote can be cast in accordance with what you believe is in the best interests of the county. There will be issues concerning flood and drainage improvements costing \$15 million, community improvement costing \$22 million and a \$75 million school bond which will fund construction of new schools and improvements to many existing schools.
