ABOUT OUR PROGRAM

This month the residents of Greenway Downs will have the opportunity of seeing Boy Scout Troop 677 and Cub Scout Troop 677 combine to perform their colorful Patriotic Opening Ceremonies. This group, which has approximately 60 boys enrolled, was organized in 1954, and has, through the years, performed many services for the community. It was the Scout Troop that first solicited funds to replace the original street signs in Greenway Downs. It seems new schemes are constantly being dreamed up to entice consumers into buying more than they can afford. This, of course, means you pay for this "privilege" of deferring paying for the things bought and this in the end means the cost of purchasing such items has been considerably more than you may be aware of. Credit buying has its place, but it is being advertised as a magic means for having everything you want with no strings attached. The truth is that credit has very strong and costly strings attached to it. Many people, especially young couples, find they are so heavily involved in credit buying that they cannot see their way out in the foreseeable future. This has the effect then of limiting their future purchasing power, and at last some firms are becoming concerned at the prospect of losing such people as customers.

With the fall season comes the chore of trying to keep up with those beautiful falling leaves we sometimes drive miles to see! Don't forget to pile those leaves where they can be cleaned up every other week according to the schedule listed in this issue. Of course, you can save the County considerably on the cost of such, and do yourself a favor, if you will mulch your leaves with your power lawn mower and incorporate them into your garden. Garden experts have been "preaching" this for a long time and I can assure you there is no better soil conditioner available than ground-up leaves, if you will just take the time and effort necessary to make use of them.

MONEY AND INTEREST

How much does that money cost? That question is the most important one the credit buyer can ask, according to Mr. Andrew Best, our September speaker. Since as high school graduates we will make around \$247,000 in our lifetimes, we should be aware of the cost of the interest tacked onto our purchases. At present Americans are spending more on interest than the entire national debt. By shopping for money as carefully as for a dress, a chair, or a house, the buyer can save substantially. For instance 6% per year is quite a bit less than 1% per month—a total of 12% per year!

Ask youself these questions before you decide to use credit for a purchase. How will the payments fit into my regular spending? How much will the credit cost? Will this product outlast the repayment time? Will my income continue for the life of this credit? and, What are the service guarantees on this product?

How much will credit cost? Check these three points to determine the true cost of credit: (1) rate of interest, (2) length of time to repay, and (3) whether charges on installment credit are figured on the unpaid balance or on the original principal.

Use the following formula to determine the "true" interest rate:

$$r = \frac{2 m D}{P(n+1)}$$

r = annual rate of interest, m = number of credit periods in 1 year, D = total charge (dollar cost), P = principal of cash advance, n = number of payments the contract actually calls for.

In addition, Mrs. Behra, President of the Virginia Citizens Consumers Council outlined the work her council is doing in informing the public and keeping an eye on legislative developments that affect the consumer. With an increased membership in the past few years, the Council hopes to have a greater voice on behalf of the consumer at the next General Assembly meeting.

The Council has also opened a telephone service with recorded messages changed twice a week. On Thursday through Sunday, a voice will advise the consumer on some aspect of food buying; on Monday through Wednesday, a voice will advise on some non-food aspect of buying. I couldn't honestly say that I had heard from our area that this was an all-absorbing interest here. If I am wrong, however, more of you need to come to the meetings and speak up. Your association can only represent you properly if we hear from you.

VOTE!


On November 5, registered Greenway Downs residents may vote for President of the United States at Devonshire School, Lee Highway and Graham Road, between 6 a.m. and 7 p.m. In addition to the presidential election, Greenway Precinct voters will decide on the \$61.9 million to finance Fairfax County's part of the rapid transit system, and on passage of liquor by the drink, and on a \$82 million state bond issue.

STORM SEWER REPORT

The construction on the storm sewer along Custis Parkway has moved along at a more rapid pace during the past month than was the case previously. The size of the two boxed culverts is correct as specified-four by six feet each. This should certainly handle the drain-off from storms in a much better manner than we have ever experienced in the past. A recent examination of the creek bed revealed that it is quite small and of course any heavy rainfall soon overflows the banks of the creek as it naturally formed. The project will end just past Cameron Road and no change in the current contract calls for it to extend to the next street, Greenway Blvd., although there had been rumors to this effect.

At the last general meeting a motion was made to have a letter written to our Supervisor, Mr. Tom Wright, asking that he try and help us with two problems in connection with this construction work. One was the dangerous intersection of Summerfield Road and Custis Parkway, and the second was the dust problem in that area due to the construction work. The letter was written and the contractor has been instructed to see that the dust is treated so it no longer causes trouble, but the State Highway Department has to act on the request we made to have Summerfield closed at this intersection until the street can be returned to its full width for traffic use. We have not been able to learn of any change affecting this intersection so far. A further report will be given at the next meeting, November 1.
